Docket call for Civil cases will be held on Monday, December 28, 2009 at 9:00 A.M. and docket call for Domestic cases will be held the same date at 9:30 A.M. **ANY ANNOUNCEMENTS OR DISMISSALS MUST BE RECEIVED IN WRITING AT MY OFFICE ON OR BEFORE NOON, TUESDAY, DECEMBER 22, 2009.**

Some of these cases are very old and will be dismissed if we receive no response from anyone. The Court **will consider** passing a case **only** if both parties agree **in writing** and **only** if **signed by the judge** before noon on December 22nd. Dismissals shall be done by the Plaintiff/Plaintiff's attorney, not by a request to the court, and must be filed prior to the above deadline. No verbal dismissals will be accepted at docket call. No verbal dismissals will be accepted at docket call and no case will be passed even by agreement of the parties if the case is more than three (3) years old. As you know, mediation must be scheduled within 30 days of the mediation order being issued.
